Park'In's Privacy Policy

1 About Park'In's Privacy Policy

Park'In conducts business in Maroc. In this privacy policy (the "**Privacy Policy**"), "**Park'In**", "we" and "us" refer to the local group company which provides Park'In's services (the "**Services**").

In this Privacy Policy, it is explained which categories of personal data Park'In collects, why Park'In collects such data, and what Park'In uses the personal data for in connection with the Services, Park'In's mobile application (the "Application") or Park'In's website www.fesparkings.com (the "Website"). This in order for you to be able to exercise your rights.

Park'In processes and handles personal data in accordance with applicable data protection law. Park'In is the data controller for the processing of your personal data unless otherwise is stated in this Privacy Policy.

Personal data is all such information which may be used to identify a specific individual (a natural person).

2 When Does Park'In Collect Information?

2.1 You

The personal data which may be processed consists primarily of such data which you, directly or indirectly, provide to Park'In. Park'In collects your personal data for example when you:

- apply for registration of an account with Park'In,
- use the Services, the Application and the Website, and when you
- contact Fes Parkings.

2.2 Information Service Provider

We may also collect personal data from information service providers in order to cross-check our customers register with public registers to ensure that we have updated and correct information. The data we collect from the public registers are also used by us in connection with communication and offers sent to you.

1.1 Credit Reporting Agencies

If you apply to pay by invoice we will collect a person/credit report from credit reporting agencies.

2 Purposes of the processing of personal data

Park'In collects your personal data for the following purposes.

2.1 Provide the Services

Park'In processes your personal data in order to provide the Services.

If you have allowed the Application to get access to location services, Park'In will collect information about your mobile phone's geographic location for the same purpose.

If you apply to pay by invoice, we will process your personal data in order to conduct a credit assessment.

¹ Park'In does not handle card details. Card details are handled by our PCI-certified service providers.

The processing of location data is based – if the processing isn't necessary for the Service in question – on your consent which you give to us by activating location data in the Application on your mobile phone. You can anytime withdraw your consent to Park'In's collecting, using and sharing of such location data by turning off the function "allow access to location data" in your mobile phone.

Storage period: The data is processed for this purpose during the customer relationship and for a time period of 36 months or, if you are a business customer, 10 years thereafter in order to satisfy Park'In's legitimate interest of defending, establishing or exercising any legal claims.

When the customer relationship ends, the personal data is stored for a maximum time of 23 months thereafter in order to satisfy Park'In's legitimate interest to fulfill the agreement with relevant parking operators.

Storage period: The personal data is retained for this purpose during a period of six (6) months calculated from the time of the communication.

1.1 Communication and Offers

Park'In processes your personal data in order to communicate with you regarding the Services, and to give you offers regarding Park'In's and Park'In's partner's services and products. By accepting the terms and conditions for the Services, you give us your consent in accordance with the Act.

You have the right to unregister from our mailing list by notifying us. Park'In ensure that marketing directly targeting you complies with applicable laws, regulations, codes of conduct and ethical guidelines regarding marketing.

Storage period: Personal data is retained during the customer relationship and for 12 months thereafter for the same purpose. The retention period for the IP-address is stated in our cookie policy.

1.1 Conduct surveys

Park'In processes your personal data in order to conduct surveys regarding Park'In, the Application and the Services, for example by asking for feedback and reviews through the Application and by e-mail.

(3) months calculated from the time of the investigation. Reports on a general level that do not contain personal data may be retained until further notice.

1.1 Follow-up and evaluation

Park'In processes your personal data in order to create different reports and statistics in order to follow-up and evaluate the Services and our interactions with you.

1.1 Handle requests

Park'In processes personal data in order to handle your requests in different channels, e.g. when you contact Park'Ins' customer service.

Storage period: The personal data is retained for this purpose during a period of six (6) months calculated from the time of the communication. Personal data regarding contacts with you are stored during the customer relationship and during a time period of 36 months or, if you are a business customer, 10 years thereafter in order to satisfy Park'In's legitimate interest of defending, establishing or exercising any legal claims.

1.1 Recording of phone calls

Park'In processes personal data in connection with recording of phone calls when you contact Fes Parkings's customer service through phone for quality and educational purposes, and for your and our safety.

1.1 Fulfil legal obligations

Park'In processes personal data in order to fulfil legal obligations relevant to Park'In, e.g. accounting obligations.

1.1 Establish, exercise and defend legal claims

Park'In processes personal data in order to establish, exercise and defend legal claims, e.g. in connection with a dispute or judicial process.

1.1 Maintenance, protection and development of the Services

Park'In processes personal data in order to maintain, protect and develop the Services, the Application and Website included, e.g. to log, develop, test and improve our Services.

Storage period: The personal data is retained for this purpose during the customer relationship and for as long as Park'In, for the respective purpose above store your personal data. For development of the Services, personal data is only used in order to anonymize them for the purpose of using the data in Park'In's test environment.

1 Your rights

According to applicable data protection legislation, you have a number of rights relating to the processing of your personal data. Some rights will

be effective as of 25 May 2018, e.g. the right to data portability. Park'In processes your personal data to the extent it is necessary to fulfil your rights. You exercise your rights by contacting Park'In's customer service. See contact details below.

1.1 Right to access

You have the right to request to receive a confirmation from us if we process personal data which concern you, and request access to the personal data we process that concern you. Some of the data we store about you are available by logging in to your personal account in the Application and on the Website. A copy of your data can be requested through our customer service.

1.2 Right to rectification

If you believe personal data registered by Park'In is inaccurate or inadequate you have the right to request that Park'In corrects the personal data. You can correct some personal data by logging in to your personal account in the Application or on the Website.

1.3 Right to oppose to direct marketing

You have the right to, at any time, oppose to Park'In's processing of your personal data in terms of direct marketing and unregister from future marketing communications by contacting customer service.

1.4 Oppose processing based on our legitimate interest

You have the right to oppose processing based on our legitimate interest for reasons relating to your particular situation. We may continue to process your personal data, even if you have opposed to the processing, if we have compelling legitimate grounds for the processing which overrides your privacy interest.

1.5 Right to erasure ("the right to be forgotten")

Under some circumstances, you have the right to have your personal data erased, e.g. if you have opposed to the processing and Park'In doesn't have any compelling legitimate grounds for the processing to continue processing the data. This does not apply if we, for example, are required under law to store the data.

1.6 Request restriction of processing

Under certain circumstances, you have the right to request restriction of the processing of your personal data. If you request restriction, Park'In may not be able to fulfil its obligations to you during the period the processing of your personal data is restricted.

1.1 Data portability

Finally, you have the right to receive a copy of the personal data concerning you in a structured format and, if technically feasible, transfer the data to someone else (data portability). The right to data portability, compared to the right to access, only includes data which you have provided yourself and which we process based on certain legal grounds,

e.g. the agreement with you (the terms).

2 Security

Park'In takes the issue of security of your personal data very seriously. Park'In

implements appropriate technical and organisational measures to protect your personal data from unauthorised access, alteration or destruction. Access to information is limited in various ways (e.g. by user authorisation and passwords being required, which are only assigned to employees who need access to such information to be able to perform their work duties). Other security measures include encryption, firewalls and physical limitations and restrictions when accessing buildings and files.

3 Transfer of personal data to other recipients etc.

Park'In shares personal data collected with the following recipients for the following purposes. The receiver is the data controller for its own processing of the personal data we share with them, unless otherwise is stated below.

3.1 Parking operators

We share data with parking operators in order for them to be able to carry out enforcement control of ongoing parking and verify parking carried out in their areas. The parking operator may also handle anonymized location data for statistical purposes.

Provide the Services

If you park in a garage, your registration number or the unique ID of the RFID card is shared between us and the parking operator in order to start and stop parking at Park'In.

1.1 Payment receiver and payment service provider

If payment is made through invoice, personal data is shared with providers of invoice payment and, in some cases, with collection agencies in order to fulfil our obligations to you in accordance with the terms and conditions of the Services with invoicing as payment method.

If payment is made through a leasing company, personal data and information about your parking is shared with the leasing company in order to make the payment associated with your car, leased through the leasing company.

If payment is made through e.g. card or digital payment methods (e.g. ApplePay and MobilePay), we only share the invoice number and amount in order to complete the payment.

1.1 Group companies

Park'In's technical platform is provided by the group company Maroc Mobilité SARLto which personal data is transferred in order for Park'In to be able to provide the Services to you.

All group companies have entered into an internal data protection agreement which purpose is to protect your personal data when they are transferred within the group of companies.

1.2 Service provider

In order to fulfil the purpose of the processing of your personal data, Park'In can share personal data with service providers. These service providers provide, among other, the

following services to Park'In: information services, phone services (PSMS), support services and IT- services, such as support, operation, improvement, development and services for handling mailings and produce cards. These service providers are only allowed to process your personal data in accordance with Park'In's explicit instructions and cannot use your data for their own purposes. They are also obliged to protect your data according to law and agreements.

1.1 Other recipients

In addition to the recipients mentioned above, Park'In can, if it is necessary, share your personal data with the following recipients:

1 Where is my personal data stored?

To the extent Park'In processes your personal data the data is stored on servers within the EU.

In order to ensure that your personal data is secure, Park'In makes sure that appropriate safeguards are in place, e.g. data protection agreements which require that the receiver protects your personal data to the same extent as Park'In.

1 Cookies

Park'In uses cookies to optimise the Services, to perform statistic evaluations, for analyses, and for marketing. A cookie is a text file stored on, e.g., your computer or mobile device, which enables identification of your computer or mobile phone. Cookies help Park'In to adjust, e.g., the Application and the Website based on your requests as a user of Park'In's Services, see further information in our cookie policy.

2 Amendments to Park'In's Privacy Policy

Park'In may amend the Privacy Policy from time to time. If any amendments are made to Park'In's Privacy Policy which imply any amendment to the way Park'In processes your personal data, e.g. collecting additional personal data for the stated purposes or processing of data for new purposes, Park'In will inform you of such amendments via, e.g., the Website, the Application or by email. Park'In recommends that you regularly read Park'In's Privacy Policy for the most recent information on how Park'In processes your personal data.
